- a. Broadband Update-Julius Hackett
  - i. Mr. Julius Hackett COOP's fiber project is winding down actively connecting members on the southern side of the county. Fiber all the way to the home affordable product, 200MB per second to 2 gigabytes per second. \$49 per month to \$99 per month, option to include telephone service. Actively connecting Duke Energy customers within 1200 feet of the mainline. Suggest to the commission what areas are priorities for the commission. One mile of fiber costs about \$70,000. We are going to invest ARPA funds to help pay for expansion.
  - ii. Don Howard Indian Hills Rd. High-speed internet service is a necessity, not a luxury anymore. Request the commission to invest in high-speed internet for the rest of the county.
  - iii. Mr. Hackett It would cost \$15-20 million to do the rest of the county. There are grant funds, the co-op will be active in those applications.
  - iv. Natalie Bender would like to get high-speed fiber for the library.
