CONSENT AGENDA ITEMS

JEFFERSON COUNTY BOARD OF COUNTY COMMISSIONERS REGULAR SESSION March 1, 2016

The Board met this date in regular session. Present were Chairman Stephen Walker, Commissioners Betsy Barfield, Benjamin "Benny" Bishop and Hines Boyd. Also present were County Attorney Scott Shirley and Clerk of Court Kirk Reams.

- 1. Commissioner Benny Bishop led the invocation and Pledge of Allegiance.
- 2. County Coordinator Parrish Barwick requested the Board move items 5f (Small Grant Application/Jefferson County 4-H) and 5h (Non-Profit Grant Application/Capital Medical Society Foundation) to the Consent Agenda.
- 3. On motion by Commissioner Barfield, seconded by Commissioner Bishop and unanimously carried (4-0), the consent agenda as amended—consisting of the approval of the agenda, the minutes of February 16th Regular Session and items 5(f) and 5(h) as described above—was approved.
- 4. Citizen Paul Henry commented on economic development.
- 5. Citizen Dan Hamedani inquired about grant funds available from the Florida Department of Emergency Management for wind storm mitigation. Jay Moseley, with Government Services, stated that this was a year-to-year grant and the county applied the previous year. He also noted that most houses in the county are not eligible due to being built on piers or the owners exceeding income thresholds.
- 6. Dick Bailar presented the Outreach Committee's quarterly report.
- County Coordinator Barwick introduced the SHIP Contract Amendment. On motion by Commissioner Bishop, seconded by Commissioner Boyd and unanimously carried (4-0), the Board approved the amendment.
- 8. Clerk of Court Kirk Reams introduced the 20121 SCRAP, SCOP and CIGP project recommendations. He listed Thomson Valley Road as the primary SCRAP project, with Main Street in Lloyd as the minor project (under \$100,000). On motion by Commissioner Barfield, seconded by Commissioner Boyd and unanimously carried (4-0), the Board approved the SCRAP recommendations. Clerk Reams stated the SCOP recommendations were Lake Road and North Drifton Road. Commissioner Barfield inquired about possibly having lane widening only and not shoulders on Lake Road. It was the consensus of the Board to amend as noted above. On motion by Commissioner Barfield, seconded by Commissioner Boyd and unanimously carried (4-0), the Board approved the SCOP recommendations. Clerk Reams stated South Main Avenue was the recommendation for CIGP. On motion by Commissioner Barfield, seconded by Commissioner Bishop and unanimously carried, the Board approved the CIGP recommendation.
- 9. Clerk of Court Kirk Reams introduced the CEI Services Recommendation item and stated that only two firms applied. He recommended approving both, with GPI the #1 ranked and Anchor the #2 ranked. On motion by Commissioner Bishop, seconded by Commissioner Boyd and unanimously carried (4-0), the Board approved GPI and Anchor for CEI services as recommended.

- 10. Commissioner Barfield introduced items 5(e) and 5(g) relating to the Small Grant &Non-Profit Grant application and committee respectively. She requested the Board approve the same committee to do the small grant and the non-profit grant and suggested appointing another person to the committee. After discussion about Jefferson County Health Department Administrator Jennifer Johnson and/or a member of the Tourist Development Council, it was the consensus of the Board that Commissioner Barfield bring back a recommendation to the next meeting. Commissioner Barfield noted that the Board did not expend all of the funds for the small grant program and requested the Board expand the program to allow for two grants per entity per year, as long as the grants were 6 months apart. Citizen Paul Henry stated that if there were funds not expended then it should go back to the Board. Citizen Phil Calandra noted that the Watermelon Festival and Southern Music Rising events were much larger in scale and perhaps should be given more money. On motion by Commissioner Barfield, seconded by Commissioner Boyd and carried 3 to 1 (Bishop opposed), the Board approved the expansion of the program to two grants per entity each year.
- 11. County Attorney Scott Shirley stated the Planning Commissioner recently met for the first time in 18 months and that they were eager to start working on a zoning map. It was the consensus of the Board to move forward.
- 12. Commissioner Bishop inquired about road maintenance crews along state roads and asked if the state had changed companies. County Coordinator Barwick stated he believed it was the same crews but with a different name. Commissioner Bishop suggested a meeting with them in the near future.
- 13. Commissioner Bishop requested a list of all committees and boards to which County Coordinator Barwick stated he had a list he could easily provide.
- 14. Commissioner Barfield requested a presentation of the list of roads to be stabilized and paved be placed on the next agenda.
- 15. The warrant register was reviewed and bills ordered paid.
- 16. On motion by Commissioner Barfield, seconded by Commissioner Bishop and unanimously carried (4-0), the meeting was adjourned.
